Just a Note

Being in the seventh grade in the sixties was full of new experiences, and one of the best was going to the C.Y.O. dances at the Assumption Church. Every Wednesday night I heard the new music that was coming out of Detroit; songs on the Motown record label from The Temptations, Smokey Robinson and the Miracles, and The Supremes. The music out of England, called The British Invasion, from Petula Clark, The Rolling Stones, and The Beatles was playing over the speakers in the rectory's hall, too. And somewhere in that mix was the sound of The Four Seasons, Sonny & Cher, Sam the Sham and the Pharaohs, and The Righteous Brothers. Oooh, just thinking of all that great music I heard at those dances brings a smile to my face. Once in a while, when I'm listening to my car's Oldies Station, one of those songs comes through the speakers, and although I haven't heard that song in decades, I belt out the tune knowing every single word! And yet daily, I find myself asking, *'Why did I come in this room?'*

We were 12!*

Arriving at Patricia's house, we put Sousa's album on the living room's stereo, grabbed our batons and began our routine. This was quickly interrupted by her mother, *"You can't be doing this here, Patricia! Your father's sleeping – he's got a 4 to 12 shift today!"* Banished, we took our batons and album to my house, where my mother's protest was: *"Nope! Not in the parlor! Go practice your twirling in your room!"* Later that day, we felt as broken as, uh, my bedroom lamp, but we were not defeated. The first round cuts were next week, and although we had 'little-to-no' baton twirling talent, we had determination.

The day had arrived, and Patricia gave a great illusion of marching while twirling her baton for the judges. Unfortunately, the judges weren't looking for a magic act. When it was my turn, about halfway through my routine, it was apparent that I wouldn't be making the team either; my 'aerial baton throw' landed on top of the judges' table. It was a good decision that the judges didn't allow flaming batons. Neither of us made the team – no surprise there!

The fate of that Military Marching Band album? My mother took possession of it and played it whenever she thought we needed motivation to complete our chores. And the Four Tops album? We wore that record out by playing it so much. Oh, and the CYO Dances? Well, there was no Wednesday night Twirling Practice for us, so we never missed a dance ... *Hey! We were 12!* 😊

SRPN RESERVE STUDY

Dues Increase Effective April 1, 2025

Why a Reserve Study Dues Increase?

Reserve Study and Funding Requirements for New Jersey Condos, Co-ops, and Planned Real Estate Developments Introduced and signed into law in 2024, New Jersey Senate Bill S2760 and Assembly Bill A4384 establish statewide Reserve Study and funding requirements for condominium associations, cooperatives, and planned real estate developments.

All condominiums and cooperatives require a Reserve Study. Planned real estate developments (i.e. Homeowners Associations) with at least \$25,000 in common area capital assets are also required to complete a Reserve Study.

A Reserve Study must be updated every five (5) years. Communities that have not had a Reserve Study in the past five (5) years must undertake an initial study by January 8th 2025.

Communities that are required to complete a Reserve Study are also required to adequately fund reserves. If an existing reserve fund deficiency would require a contribution increase that exceeds 10% of the annual budget, the community has ten (10) fiscal years to attain adequate funds through the use of proportionate annual increases or until the date projected in the Reserve Study that the reserve fund balance would fall below \$0.00. If the reserve contribution increase is no more than 10% of the annual budget, a community has two (2) fiscal years to make up an existing deficiency.

What are adequately funded reserves?

A Reserve Study determines how much a community needs in reserve funds to support the timely repair and replacement of common assets. Community Associations Institute (CAI) defines adequate reserves as “a replacement reserve fund and stable and equitable multiyear funding plan that together provide for the reliable and timely execution of the association’s major repair and replacement projects without reliance on additional supplemental funding”. Different Reserve Study firms may use different funding methods.

What if we cannot meet the funding requirements outlined in our Reserve Study?

The Reserve Study takes into account the sufficiency of existing reserve funds and presents a recommended funding plan that complies with state statutes. Funding recommendations are the direct result of near-term project needs and there may be cases where it is difficult, if not impossible, to meet the immediate funding needed to address them. We encourage you to meet with your Reserve Study consultant to review their recommendations and determine the merits of adjusting their recommendations, which may or may not alleviate the ability to attain appropriate funding levels. In the event your association is still unable to meet its funding obligations set forth by New Jersey Senate Bill S2760, we encourage you to consult with legal counsel to better understand the risk associated with being non-compliant.

If a reserve shortfall is identified through an updated study, associations must immediately begin making up the deficiency through dues increases and other budgeting methods. However, if doing so would require an increase in unit owner dues in excess of 10% and depending on the nature and extent of the shortfall, associations will have up to 10 years to make up the shortfall.

IMPORTANT INFORMATION

S R P NORTH HOMEOWNERS

ARCHITECTURAL COMMITTEE

Prior to obtaining a permit from the Berkeley Township Construction Office and/or Zoning Office, homeowners must obtain a "Architectural Approval Request" form from the *Architectural Committee*. Sheds, upgrades, renovations, repairs, additions, exterior changes, anything pertain to the grounds, trees, driveway construction and sidewalks all require approval from the Architectural Committee. **Note:** Homeowners may need to submit a Zoning Permit Application, required fees, and forms to the Berkeley Township Town Hall/Zoning Office. Contact the Zoning Office for instructions.

COMMON GROUNDS

No debris, grass cuttings, landscape material, leaves, old plants, tree branches should be dumped in the common grounds. **Violators are subject to Berkeley Township fines.**

LAWS GOVERNING S R P NORTH

Mandatory Federal, NJ State, Berkeley Township Laws, SRPN Association Covenant-Restrictions and By-Laws and Robert Rules are instruments of the rule of law that the sitting Board of Trustees must follow to meet their obligations.

- Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Act)
- The Housing for Older Persons Act (HOPA)
- NJ State Public Law #L90-284 and PUB 100L430 Guidelines for the operation of senior communities.
- Berkeley Township Ordinance #118-1625. The establishment of a planned residential community for older adults. • Silver Ridge Park North's Covenants and Restrictions/By-Laws.
- State of New Jersey Full Disclosure Act and Regulations Title #5.

SELLING/RENTING OF HOMES

When selling your home, either on your own or through a Real Estate Agent, you must notify the HOA **BEFORE** your buyer completes the 'New Purchaser's Packet' and provide the HOA with two (2) forms of identification; one being a photo ID showing birthdates for each occupant of the home. (See pg.2 for appt. information)
SRPN By-Laws require one (1) year homeowner's ownership prior to renting their property.

Landlords AND Tenants must complete the HOA's 'Lease Agreement Packet' and provide the HOA with two (2) forms of identification; one being a photo I.D. showing birthdates for **each occupant and a copy of the Lease.**

All buyers and tenants (all residents) **must appear in person** at the HOA office with the required identification and paperwork. **Berkeley Township will not issue a C.O. (Certificate of Occupancy) without the HOA's Letter stating the buyer/tenants are in good standing with the Homeowners Association.**

SIDEWALKS

It is each homeowner's responsibility to repair and maintain sidewalks on their property. All lifted and cracked sidewalks require repair at the homeowner's expense.

TREES

It is the homeowner's responsibility to prune and maintain trees located on their property. Also, **no tree in the common ground, or wildlife corridor, may be pruned, removed, or topped for any purpose, including installation of solar panels.** Trees in these areas needing attention should be brought to the attention of the *Common Ground Trees Committee*.

OTHER IMPORTANT REMINDERS

- Parking/storage of inoperable, unregistered, or uninsured motor vehicles, boats, or any other watercrafts, trailers, and/or recreational vehicles are not allowed anywhere on your property or Common Grounds.
- **Berkeley Township Ordinance:** Trash/garbage is to be put out at the curb **AFTER 4:00pm** on the day before a scheduled pickup. **RECYCLED ITEMS** are to be placed curbside, in reusable containers or paper bags, **AFTER 5:00pm** on the day before a scheduled pickup.
- All pets are required to be leashed. You must pick up and remove your pet's waste, even if you walk them in the common ground area.
- It is the Homeowner's responsibility to maintain their grass and/or stone lawns.
- **A Berkeley Township Ordinance strictly prohibits the feeding of wild animals** consisting of, but not limiting to, the following: DEER, rabbits, squirrels, chipmunks, and groundhogs. Wild birds are excluded.

Ocean County Transportation Services Department

Seniors (age 60 and over) and/or persons with disabilities (age 18 and over) on an advanced reservation basis primarily to destinations within Ocean County. **Pre-registration is NOT required, just call us when you need your appointment.**

You may call Ocean Ride Monday through Friday only, from 8:00 AM to 4:30 PM to make your trip reservation. We accept trip reservations on a first-come, first serve basis, up to (4) four weeks in advance. **All trip requests are to be handled by telephone by calling (732) 736-8989, then press "1" to speak with a Reservationist.**

The Reserve-A-Ride program is primarily designed to serve routine medical needs of Ocean County residents. Unlike the Fixed Bus Routes, this service does not operate on the basis of a printed schedule, rather routes and pick-up times are developed each day in response to the service requests we receive. **All vehicles are wheelchair lift equipped.**

Once your reservation has been made, **the driver will arrive anytime within 1 hour to 1½ hours of the scheduled appointment time** (depending on your travel distance). In accordance with Ocean Ride's Safety Policy, our **Drivers are NOT permitted to enter your home**, thus we **require that you be at ground level for your scheduled pick up.**

Riders will be billed via mail, the month AFTER service.

Silver Ridge Park North Shed Rules

After discussion regarding sheds at the Silver Ridge Park North (SRPN) Trustee meeting, held on Tuesday, April 7, 2015, the Trustees unanimously agreed to Rules 1-8. Updated Permit/Form information - February 2019.

1. In keeping with Berkeley Township's Shed Ordinance, homeowners are permitted, effective this date, to install one (1) shed on their property; up to and including 120 square feet (10 ft. x 12 ft.);
2. Said shed may be of any structure material the homeowner desires;
3. Sheds that are required to be fastened must be on a firm ground structure. DO NOT place any shed on a cement slab. Cement slabs add square feet to your taxable living space and will be taxable by Berkeley Township;
4. Sheds may NOT be installed on any Common Ground Property;
5. In accordance with Berkeley Township Ordinance, sheds must be placed at least three (3) feet from the back property line and at least (3) feet from the side property line;
6. If a homeowner chooses to install a shed adjacent to their home, it may NOT block any windows or doors;
7. Homeowners MUST submit an Architectural Approval Request form to the SRPN Architectural Committee. *Architectural Approval Request forms are available in the SRPN Clubhouse Lobby;*
8. The homeowner MUST submit a **Zoning Permit Application**, required fees, and forms to the Berkeley Township Town Hall/Zoning Office. *Zoning Permit Application forms can be obtained from the Berkeley Township Website or Zoning Office.*






